The above petition came before the Environmental Board for hearing on April 14, 1976.

Appearing before the Board were:

James H. Rifkin, Esq., representing the Town of of Whitingham, petitioner;
Timothy J. O'Connor, Jr., Esq., representing Lawrence Fownes, property owner;
Stephen B. Sease, Esq., representing the Agency of Environmental Conservation.

The issue before the Board is whether a certain road located on property owned by Lawrence Fownes to provide access to a subdivision was constructed and in existence prior to June 1, 1970, the effective date of the permit requirements of Act 250, Chapter 151 of Title 10.

## FINDINGS OF FACT

- 1. Lawrence Fownes proposes to divide into 8 lots certain property owned by himself located on Lake Sadawga in the Town of Whitingham. The plan for the subdivision is shown on petitioner's 3(C). Fownes represents that deeds will contain covenants which will prohibit resubdivision of lots.
- 2. The road located on the property as shown on petitioner's 3(C) and on a 1970 aerial photograph (Fownes 1 and 2) was constructioned by Haynes Brothers, Inc. in 1965 (Fownes 3).
- 3. Fownes has not constructed improvements for a road or roads on the property while owned by himself at any time after June 1, 1970.

## CONCLUSIONS OF LAW

The road to serve the proposed 8 lot subdivision is exempt from the permit requirement of Act 250 under the provisions of 10 V.S.A. \$6081(b) by being a development which was commenced prior to June 1, 1970 and was completed by March 1, 1971.
