Respondent committed the following acts in violation of Vermont Law, Statute, Rule, or Permit:

Violation Citation: Failure to abide by approved hours of operation

Description: Respondent is owner/operator of the Rocky Ridge Raceway (905 Pirie Road, Williamstown) which is under Land Use Permit (LUP) 5R1478. Condition 9D of LUP #5R1478 limits operation of the racetrack to Fridays, Saturdays, and Sundays, with occasional Monday practices. In response to a complaint alleging unauthorized racetrack operations, the Natural Resources Board's Enforcement Office reviewed the Rocky Ridge Raceway's website (https://vtshifterkarts.com) which included documentation of 15 completed racing events (with posted results) during the 2021 and 2022 operational seasons occurring on days of the week not authorized under Condition 9D of LUP #5R1478.
