NOTICE OF JURISDICTIONAL OPINION RECONSIDERATION

On May 20, 2016, the Vermont Natural Resources Board (Board) received a request from Viateur Fecteau, Patricia Fecteau, and Fecteau Residential, Inc. (Requestors) to reconsider Jurisdictional Opinion #5-32 (the JO). The JO, issued by the District 5 Coordinator on April 21, 2016, which found that 11 lots have been created within a continuous five-year period and therefore an Act 250 permit is triggered. The Board will reconsider the JO in accordance with 10 V.S.A. § 6007 and the Interim Procedure on Reconsideration available online at: <http://www.nrb.state.vt.us/policies/recon.pdf>.

The JO, the reconsideration request, and related materials are available online. To find the materials for this proceeding, go to the Act 250 database <https://anrweb.vt.gov/anr/vtanr/Act250.aspx>, enter JO 5-32 in "Project Number," and click "Search."

Replies to the reconsideration request must be filed with the Natural Resources Board by June 21, 2016. Replies should specify which aspects of the reconsideration request or the JO are at issue, the reason you think the reconsideration request or JO is in error, whether you wish to present any additional evidence, and the decision requested of the Board. Any request to present additional evidence must: (1) identify the proposed new evidence, (2) explain why it is material, (3) explain why good cause exists for the person's failure to provide the additional information to the District Coordinator, (4) state whether a hearing is requested or, if any of the additional evidence can be submitted by other means, state how the additional evidence can be presented.
