LAWS/REGULATIONS INVOLVED

10 V.S.A., Chapter 151 (Act 250)

The Vermont Environmental Board hereby issues a Land Use Permit Amendment pursuant to the authority vested in it in 10 V.S.A., Chapter 151. This permit applies to the lands to be identified in the Land Records of Belvidere, Vermont, as the subject of deeds and easements to the Agency of Transportation, the "permittee" as grantee. This permit amendment specifically authorizes the permittee to amend Land Use Permit #5L0083 to broaden the curve located generally between stations 154 and 158 with accompanying construction in the streambed of the North Branch of the Lamoille River, to relocate the Otter Brook as specified in the plans, to demolish a house located near the Elementary School, and to realign the road between stations 260 and 276.

The permittee, its assigns and successors in interest, are obligated by this permit to complete and maintain the project only as approved by the District Commission in accordance with the following conditions:

- 1. The project shall be completed as set forth in Findings of Fact and Conclusions of Law #5L0083-2-EB, in accordance with the plans and exhibits stamped "Approved" and on file with the District Environmental Commission, and in accordance with the conditions of this permit. No changes shall be made in the project without the written approval of the District Environmental Commission.
- 2. By acceptance of the conditions of this permit without appeal, the permittee confirms and agrees for itself and all assigns and successors in interest that the conditions of this permit shall run with the land and the land uses herein permitted, and will be binding upon and enforceable against the permittee and all assigns and successors in interest.
- 3. The District Environmental Commission shall maintain continuing jurisdiction during the lifetime of the permit and may periodically require that the permit holder file an affidavit certifying that tht: project is being completed in accordance with the terms of the permit.
- 4. This permit amendment hereby incorporates all conditions of the Stream Alteration Permit issued on June 25, 1979 by the Regional Engineer, Division of Protection, Agency of Environmental Conservation.

- 5. This permit amendment hereby incorporates all conditions of the Department of the Army Corps of Engineers Permit No. 10840 issued on January 10, 1979.
- 6. This permit amendment hereby incorporates the terms of the Agreement between the Agency of Transportation and the Town of Belvidere, dated March 24, 1981.
- 7. All construction on this project must be completed by June 12, 1983.
- 8. This permit shall expire on March 15, 1992, unless extended by the District Commission.
- 9. Notwithstanding, this permit shall expire one year from date of issuance if the permittee has not demonstrated an intention to proceed with the project.
