Any appeal of this decision must be filed within 30 days of the date the decision was issued, pursuant to 10 V.S.A. Chapter 220, with the Superior Court, Environmental Division, 32 Cherry Street, 2nd Floor, Suite 303, Burlington, VT 05401.

The Notice of Appeal must comply with the Vermont Rules for Environmental Court Proceedings (V.R.E.C.P.). The entry fee (\$265.00 as of July 1, 2014) must be filed with the Notice of Appeal.
